#### Your Submission:

I think a flat water sports facility should be listed as a high priority in the current plan. I also think that an effort should be made to improve the quality of the water at Kerrs Reach. I think the health and safety of our athletes are being compromised with what is available at present.

#### 1. Consider what -

Kerrs Reach is grossly overcrowded, not only with rowing but also with diverse other craft, such as Dragonboats, outriggers, surf boats & kayaks which all have different manouverability. The number of crashes and close calls is alarming. It is very dangerous particularly when users do not follow the rules of the river as there is no room to take evasive action. This situation is aggravated at low tide when there is even less room. An alternative consideration is the limit of room to expand to cater for new schools that have expressed a desire to row. There is no room to accommodate them.

### 1a. Specific Action -

Put an alternative flat water facility on the Plan as a very high priority. The Council should continue to investigate a new facility at Halswell or some other handy location.

## 1a. Why -

This will reduce congestion on Kerrs reach, will open up the opportunity for other people to become involved in rowing, not least other schools who would find it very difficult if rowing is limited to Kerrs reach. It seems to be a win win situation if asuch a facility also has benefits for drainage in the area.

## 1b. Specific Action -

The Council could investigate the introduction of gates or a weir on the Avon river between the Pages road bridge and the estuary, that would keep the level of water in the river at a more useable level during the day.

1b. Why? -

The level of water in the river, basically every second week due to the tide, is low which reduces space on the river and consequently increases the risk of having an accident significantly.

#### 2. Consider what -

The water quality at Kerrs Reach is very poor, at best, and is highly suspect, at worst. The pollution frequently exceeds World Health recreational

standards.

2a. Specific Action -

There should be an effort to reduce the number of birds in the area. 2a. Why -

My daughter got a infection from stepping in the river which required antibiotics to settle down but it still comes now and again. The pontoons have improved the situation as rowers do not have to enter the water as they did before. However her friend recently got a splash on her leg as she was rowing along which resulted in an infection on her leg at that point. This is a very common occurence.

2b. Specific Action - The Council could look at purchasing another weed cutter to better manage the weed in the river. While the guys presently working there do a great job, they simply can not keep up. 2b. Why? -

There have been several occasions when poeple have fallen out of boats amongst the weed and they have struggled to get to shore, particularly if they have to pull their boat with them.

Sometimes it is the weed that causes the rowers to fall out by catching the oars in the water.
