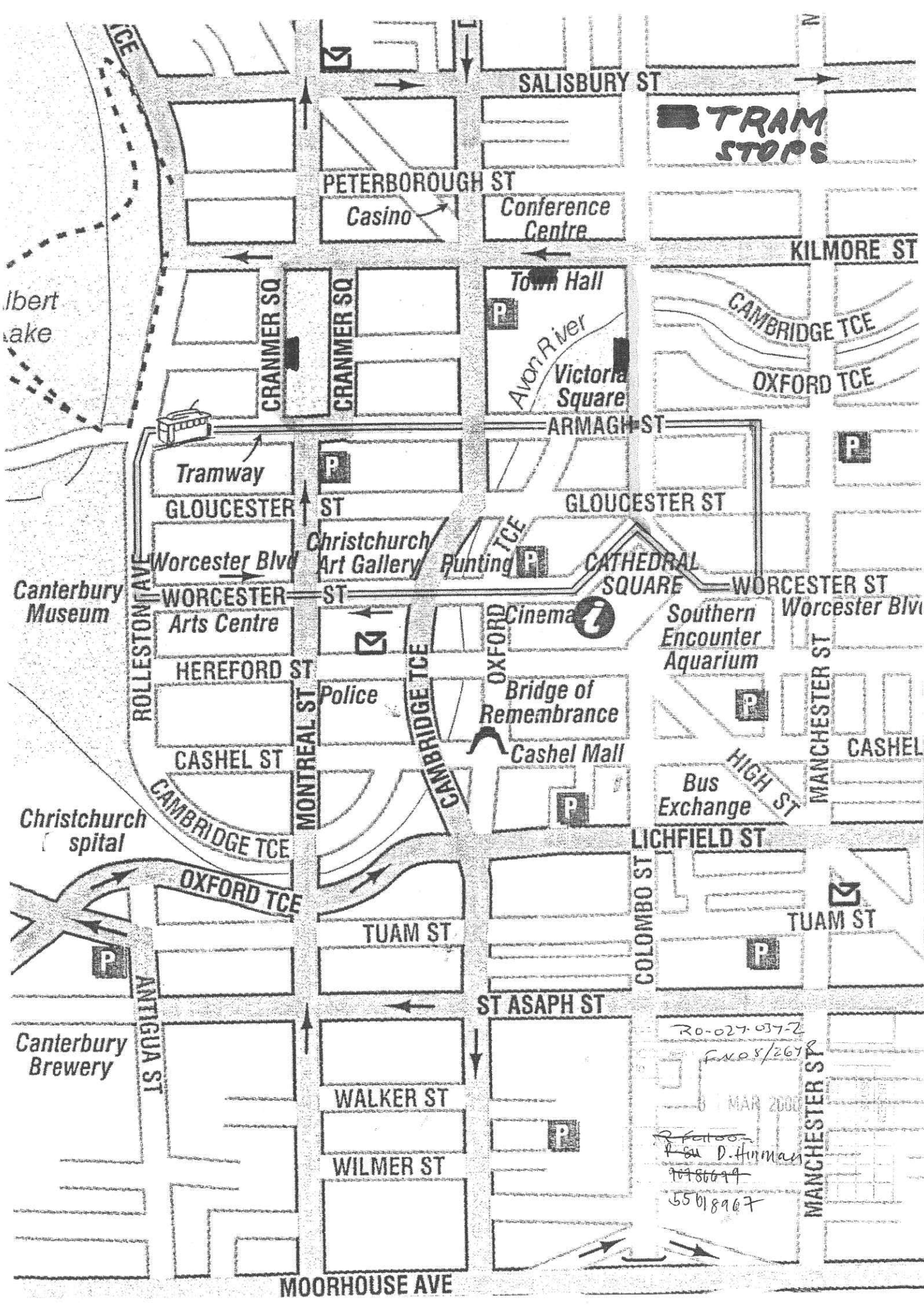

With reference to the extension to the Council's tram route, the proposed extension is impractical as it would be a danger to pedestrians in Cashel and City Malls.

It would also cause traffic congestion in Manchester Street and Oxford Terrace. Several trees and the pedestrian overbridge in Cashel Street would have to be removed. The road round the back of the Cathedral is too narrow for safety. There is nothing on the proposed circuit that would be of interest to tourists.

A much more attractive and practical extension would be for the tram to travel north of the Square - Colombo St, Kilmore St and Cramer Square West, then rejoin the circuit at Armagh St. This extension would be far less expensive to install.
