*Submission from Ross Ferguson on behalf of Shirley Residents Group May 2004.
To be presented to City Plan.*

Since the time of amalgamation between the CCC and the Waimari County Council the householders of Sabina, Hercules and Hammersley Ave, have been requesting that the old gutters would be replaced by kerbing and channeling to make the streets uniform.

The serious flooding problem at the north end of Sabina St. has been used as a delaying tactic by the Engineers. Extensive work has been done to help solve this problem.

In the plans I received on 17-01-01 there seems to be only one more structural change to be made.

The installation of 4 new sumps has relieved the situation to a point, but the final installation of a 250mm pipe in Hercules and Sabina Sts will clear the flooding situation. *(Photographs to be produced)*

When the drainage pipes have been installed, possibly at the same time to save disruptions, new kerbing and channeling can be installed.

The old Waimari gutters are in a very bad condition and must be past their “used by” date as they are over 55 years old. There are places where there is seepage under the road surface as the beds of the gutters are breaking up. The local residents have petitioned on several occasions to have kerbing and channeling installed and have been on the 5 year plan and the 4 year plan but have fallen off because other areas not in as bad condition have swallowed up the funds intended for this work.

Since the construction of the Palms our traffic flow has increased four fold, which has resulted in the Staff parking extending into all smaller surrounding streets including Hope, Sabina and Hercules.

With the installation of the Kerb and Channeling cars could park closer to the kerb.
