We would like to lodge an interest in the work being done on Blighs Road over the next 3 years and how it will impact on us the Residents of Ashmore Lane. Would it be possible to see a plan and time-line for the work which will be undertaken? Would it be possible to have an on-site meeting before the plans are finalized?

Items of interest are

- Will there be Underground wiring for power and phone cables?
- Will the street lights be renewed?
- · What footpaths will be designed?

Ideas that have been put forward are as follows

- A large street light at the end of the lane to mark this entrance way.
- Restriction of parking at the entrance, so people can have a clear view of traffic coming from the left or right when using the Lane.

Areas of concern are as follows

- There are 14 people rubbish bags and recycle bins, (not including bins from the 3 houses from 147A Blighs Road) which are left at the bottom of this Lane every Friday morning, this requires that we maintain a large expanse of paving on which to leave the rubbish for collection.
- We currently have a tasteful brick entrance way and would expect this to be retained. It could be improved if it was made wider (< 6 metres) to accommodate 2 cars (i.e one pulling out of the lane, and one pulling into the lane.) Waimairi Primary school is very close this would allow additional visibility to both pedestrian and traffic.
- It is important to retain the existing signs at the head of the lane, and by adding a "No Exit" sign, under the private Lane sign, as we have people driving up the Lane thinking it is a short cut to Blair Ave.
