I note in the Community Plan sums of approximately \$20,000,000 to be spent on strategic purposes each year. I have heard that included in these sums is money to buy land in the Henderson Basin for stormwater purposes. Such land purchase will hopefully continue to help protect the Cashmere Stream and Heathcote River from major flooding by ensuring that the land continues to function as a ponding basin. Even more hopefully the land can be purchased and then modified by the City Council to in fact reduce the risk of major flooding downstream while at the same time provide flood mitigation to sufficiently mitigate the effects of all past and future upstream subdivisions.

Back in 2002 the owners and Christchurch City Council staff had meetings to determine how the land owners could develop their land and at the same time enhance the flood mitigation provided by flood ponding in the Henderson Basin. At this time all owners were prepared to gift land to the Christchurch City Council so as to enhance the local environment in exchange for rezoning the remainder of their land to medium density residential user. Some owners were prepared to gift approximately half their land to the City Council. Unfortunately the City Council staff terminated these discussions while they proceeded with Variation 48.

I note that the City Council is struggling to meet all needs without large rate rises, and is talking about saving a few hundred thousand dollars by closing libraries and pools, which has not been received well by the Community. It would appear that savings of tens of millions of dollars could be made by restarting and concluding the previous negotiations with the landowners of the Henderson Basin.

We look forward to an enhanced Henderson Basin, a much better environment and substantial savings to the ratepayers of Christchurch.
