1. The CHRISTCHURCH BOTANIC GARDENS.

On page 11, Lesley McTurk says "The council is constantly being asked for more, such as enhanced facilities at the Botanic Gardens"
I object strongly to that loaded statement.

The Christchurch Botanic Gardens have been sadly neglected for many decades (long before Lesley McTurk came to Christchurch). That is well recognised.

And that is why our good city councillor Alister James enabled the Christchurch Botanic Gardens to be allocated some catch-up funding in the LTCCP in 2004 for 2007 onwards.

Do not allow over-funding of the Canterbury Museum to influence lower capital expenditure for the Christchurch Botanic Gardens, for goodness sake.

pages 59, 73, 83, 83, 85, and 127 allow for modest spending in capital works and operational expenditure for the Botanic Gardens.

But the Christchurch Botanic Gardens still remain the poor little Cinderella in the proposed Activity Operational Costs on page 127: 2006/07 at \$4,848,000 - up to 20015/16 at \$6,061,000

compare that with the Canterbury Museum on page 107 Activity Operational Costs: 2006/07 at \$6,263,000 - up to 20015/16 at \$12,175,000

That is a dismal comparison for our glorious, well-used and much loved Christchurch Botanic Gardens - isn't it?

2. CHRISTCHURCH PUBLIC LIBRARIES.

page 86. "Proposals to Cut costs, reduce spending"

DO NOT TOUCH OUR LIBRARIES. After all the wonderful stewardship of our libraries by Sue Sutherland, allowing Christchurch people much better access to the inspiring treasures, we are up in arms about the pathetic attempts to save pennies by shutting down some of those very worthwhile gains that Sue Sutherland implemented for us.

Instead, we should take a hard look at the City Council's expenditure on the Canterbury Museum.

Now why on earth isn't the Canterbury Museum featured
at all on this page?
After all, the Canterbury Museum is a bottomless pit
of funding and grants from the Christchurch ratepayers

How will we know if we achieve our objective?: "Funding applied as per the Canterbury Museum Annual Plan."

Come on, Councillors, JUST SAY NO. Every year the proposed Museum's Annual Plan is presented to the Christchurch City Council and the other smaller council's for their ENDORSEMENT. Get real. It's money for jam!

I plead with you to honour your obligation which is to provide the required funding. NOT the extravagant demands of the Museum Board.
