On behalf of St Mary's, Addington, representing 74 people.

Issue:

Closure of libraries.

Submission refers to P.8 of Summary Version.

Actions recommended to Council:

1.) Keep all libraries open.

2.) Review the priorities which govern City Planning, placing the people of Christchurch, especially the disadvantaged, first.

Why should that be done?

1.) Keeping all libraries open:

Branch libraries are used by

a. Elderly people. Many do not drive.

b. Disabled people - all kinds of disability. Most of these people do not drive.

c. Schoolchildren, who walk or cycle.

d. Mothers with preschoolers.

Since many of these people would be unable to travel to a more distant library, if their local library were to close, they would miss out on education, enjoyment, company, a goal for exercise, all summed up as quality of life.

Many of the people in these categories may find it difficult to make a submission, and many could be put off by the complexity of the submission form.

2.) Review the priorities which govern City Planning, attending first to the people of Christchurch, especially the disadvantaged.

a. So that future planning does not overlook the disadvantaged.

b. So that the few thousand dollars represented by the Branch Libraries and other community programmes, including Council Housing and Community Cottages, be considered money well spent.

Where can money for libraries come from? Central City Marketing.

If libraries were closed the saving would be very small against the millions budgeted elsewhere.
