I write in opposition to two points on page 86 of the Draft LTCCP entitled "Council's Proposed Savings":

- Rationalise community libraries (eg. Closing Redwood, Bishopdale and Spreydon)
- Exit mobile library

I strongly disagree with the closure of libraries in the city, most specifically Redwood, Bishopdale and the mobile library.

These libraries are well used and hugely valued by those that use them. To close them down would be to rob the local communities of an important resource.

There is a significant elderly population in both the Redwood and Bishopdale areas, and it would be very difficult if not impossible for many of these elderly residents to travel further to use alternative public libraries.

It is also very important for some of my constituents in the Belfast area to be able to use the mobile library when it stops in their area once a week.

The only rationale behind the proposed closure of these libraries appears to be to save money. I believe that closing down key services in order to save money is a very poor judgement call, which would be viewed extremely unfavourably by the majority of the public especially if rates simultaneously go up.

I have received a huge number of letters and phone calls from concerned constituents since the proposal to close these libraries became public. I have no doubt that it would be strongly against the wish of the community to close any of these libraries, and that to proceed with the idea would result in a huge public outcry.

As evidence of this, please find attached a list of names of 70 people wishing to join my submission. In addition to these names I have been verbally asked by a number of other people to represent them through my submission.

Some of these members of the community have asked that I lead a delegation to the Council when I come to present my submission. May I request that my time be set on a Friday as I am unavailable in Christchurch on the other days of the week due to Parliamentary obligations.
