Page 6. Our future direction. Population Growth.

We are never asked what this should be. The Government is the same. Do we just grow with no thought to the infrastructure?

400 new arrivals each month was quoted in the newspaper. This is too many to keep up demands on our facilities. i.e. water, healthcare, electricity, roading, prisons schools, housing, etc.

Community outcomes. If, as you say Christchurch residents have identified these as important to our wellbeing what is going to happen to our health system? It is obvious our population is growing too fast to keep up with demands on our health workers.

We do not live in a city free from crime. Almost every day there are attacks on citizens or cars and homes are burglarized.

Christchurch is known to have the most drug addicts and prostitutes living here plus the City of STI's.

Christchurch has more households on fixed incomes than elsewhere so rates must be kept at the level of inflation.

Page 4. Proposed major projects and proposals.
